CITY COUNCIL RESOLUTION 2025-024
APPROVING PLANS AND SPECIFICATIONS AND
AUTHORIZING ADVERTISEMENT FOR BIDS
2025 RECLAMATION AND OVERLAY PROJECT
STRT2025-A80

WHEREAS, City staff has prepared plans and specifications for 2025 Improvement No. A80 – 2025 Reclamation and Overlay Project; and, has presented such plans and specifications to the Council for approval; and,

WHEREAS, the following improvements are included in Improvement No. A80:

- Laurel Court (Pavement Reclamation)
- Industrial Drive (Pavement/Road Section Replacement)
- Maple Street from Jefferson Parkway to Ford Street (Mill and Overlay)
- Lake Drive from Jefferson Parkway to Maple Street (Mill and Overlay)
- Superior Drive from Erie Drive to Maple Street (Mill and Overlay)
- Maple Street from Jefferson Parkway to Ford Street (Off-Street Trail)
- Laurel Court (Off-Street Trail)
- Maple Street and Superior Drive (Crossing Improvements)
- Superior Drive (Crossing Improvements)

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL THAT:

1. Such plans and specifications, copies of which are available on the City of Northfield’s website, are hereby approved.
2. The City Clerk shall prepare and cause to be inserted in the official paper, Northfield News, and on the MnDOT e-Advert website, advertisement for bids upon the making of such improvement under such approved plans and specifications. The advertisement shall be published for 21 days, shall specify the work to be done, shall state that bids will be received by the clerk until 2:00 p.m. on March 20, 2025 at which time they will be publicly opened in the Council Chambers of the City Hall by the City Clerk and City Engineer, will then be tabulated, and will be considered by the Council at 6:00 p.m. on April 1, 2025, in the Council Chambers of the City Hall. Any bidder whose responsibility is questioned during consideration of the bid will be given an opportunity to address the Council on the issue of responsibility. No bids will be considered unless sealed and filed with the Clerk and accompanied by a cash deposit, cashier’s check, bid bond or certified check payable to the Clerk for five percent (5%) of the amount of such bid.
