- *Community Engagement Campaign: Energy Efficiency, HVAC Contractor and Homeowner Education: Commissioner Anderson reported on his discussions regarding training and certification with local contractors offering heat pump installation. Commissioner Hanson reported on plans to offer a public educational event regarding energy savings, incentives, and rebates. Assistant to the City Administrator Risi Karim provided information on already-scheduled Zero Waste ordinance open house dates in the Fall of 2025 where this outreach might be appropriate. The EQC discussed additional options for public outreach events.*
