City Council discussion on the 2026 Mill and Overlay and Mill Towns State Trail Project Feasibility Report and Crossing Improvements.

Engineering Manager Sean Simonson introduced the item and introduced Engineer Bryan Nemeth with Bolton and Menk. Simonson gave background on the project to include the project scope, project location, what a mill and overlay is; proposed improvements; and crossing improvements. Nemeth reviewed the Pedestrian Crossing Analysis for Jefferson Parkway Improvements. Simonson reviewed public feedback from the neighborhood meeting, preliminary cost estimate/funding and the project timeline.

City Administrator Ben Martig added comments regarding Council feedback on the Prairie Street protected bikeways and other feedback for consensus and expediting the project. Public Work Director/City Engineer David Bennett added additional information. The Council added feedback on the project.

Simonson, Martig, Bennett and Nemeth answered questions from the Council.

2. 25-277 City Council discussion on the Woodley Street and Spring Creek Road Intersection.

Engineering Manager Sean Simonson introduced the item. Engineer Bryan Nemeth, Bolton and Menk, presented on the project giving background information, pedestrian and bicyclist volumes, traffic analysis, safety review, traffic control, warrant thresholds, all-way stop implementation outcomes, current recommendations and future

recommendations.

The Council added feedback on the project. Nemeth, Simonson and Public Works Director/City Engineer David Bennett answered questions from the Council.

Hoffman reviewed pending initiatives to include standardizing City Code (Phase 2); reviewing the role of Council members on boards, commissions and committees; reviewing board/commission appointment timeline; reviewing specific boards/commissions scope; and reviewing the size of boards/commission.
