Christine from Minneapolis, gave a brief overview of her past dealing with abuse and addiction. She noted that finding Restore Recovery has saved her from going back to a horrible lifestyle.

Meg Gautheir, board member - talked about the mission of Restore Recovery. Asking for \$4,000.00 to help women like Christine. The money would help with a security deposit and first months rent for 2 women.

Housing Coordinator Melissa Hanson introduced this item noting the HRA went to Redwood Falls to take a tour of Schult Homes, where they build manufactured homes.

Each board member gave their feedback of the tour: Board Member Crow- happy to start the conversation on options for what to do with this land. Cons - homes are built on metal chasses that is permanent, affordability, need a separate shelter for severe weather (HUD regulation), accessibility (they have stairs). Board Member Hager Dee - sent Corey a thank you from us. Still concerned about affordability, impressed with quality, unattractive skirting on the home, is it real property from a title standpoint? Vice Chair Gerdes - thankful for the tour, was impressed with the durability, provided space and amenities that was attractive. Board Member Thomas - was unable to go but saw the presentation and has additional questions on financing and who are they affordable for? Board Member Zuccolotto - was unable to go but noted that Northfield needs density & growth and is excited to start the conversation on this.
