#### Summary Report:

The following is an update on agenda items as supplemental background agenda information made available for Tuesday April 1, 2025:

## 1. 25-188 Presentation from Earth Day Steering Committee.

Amy Haslett-Marroquin and Sarah Fortner, members of the Northfield Earth Day Celebration Committee, will attend the upcoming council meeting to present highlights from this year's Earth Day celebration. The event, scheduled for Saturday, April 26th, will feature a variety of activities, including educational exhibits, interactive workshops, and a panel discussion with local sustainability leaders.

Northfield has a strong history of climate action, with initiatives focused on renewable energy, water conservation, and community wide sustainability efforts. The city has taken significant steps to reduce its carbon footprint, including the adoption of a Climate Action Plan and collaborations with local organizations to promote environmental stewardship. # 18. 25-198 Council Request to Review 1% for Arts.

Staff received a request for a summary of past revenues for Arts funding. Finance Director Angelstad and Library Director Draper are out but can verify the actual amounts later. This is an estimate of the transfers, but it will require verification:
