2025 Work Plan Updates

- *Zero Waste Plan Implementation: The single-use bag town hall has been canceled. The survey will remain open to the public until September 12, 2025.*
- *Community Engagement Campaign: Energy Efficiency, HVAC Contractor and Homeowner Education: Commissioner Anderson reported that he has heard back from the Minnesota Center for Energy and the Environment and they are interested in hosting a virtual meeting with HVAC contractors in the Northfield area. Members of the EQC and City staff will meet with this organization on Thursday, August 21, 2025. Anderson also reported that the Minnesota Department of Commerce plans to continue their rebate programs for home energy efficiency upgrades.*
- *Native Planting Ordinance: Tree Planting & Vegetation: Commissioner Jones sent a draft of an advisory memo to be approved by the EQC and sent to City staff. The subcommittee working on this initiative would like the City to tie urban forestry management to the Land Use Code. Commissioner Petri raised the issues of local trees regarding fireflies and tree limb loss.*
- *Water Quality & Conservation: Commissioner Shmurak reported that this subcommittee is waiting to hear back from City staff regarding publicity materials. Commissioners Shmurak and Podracky wish to include discussion of pesticide use in this initiative.*
- *Research Level 3 Charger use & need: This initiative has been completed.*
