ACCEPTING MONETARY DONATION RECEIVED FOR NEW ICE ARENA PROJECT

- WHEREAS, the City of Northfield (the "City") is authorized to accept donations/gifts of real and personal property pursuant to Minnesota Statutes, Section 465.03 for the benefit of its citizens and in accordance with the terms prescribed by the donor, and that acceptance of such donations/gifts are subject to a resolution of the City Council adopted by a two-thirds majority of its members; and
- WHEREAS, the City Council of the City has taken several prior actions to proceed with the construction of a new municipal ice arena facility (the "Project") to be located on certain real property located in the City of Northfield, Rice County, Minnesota (PID No. 22.11.1.54.009) (the "Property") for the benefit of the community; and
- WHEREAS, the Northfield Hockey Association, Inc. (the "NHA"), and its fiscal agent Northfield Shares (collectively the "Donor"), desire to assist the City with the construction of the Project on the Property by making a monetary donation to the City for the Project, which is the culmination of extensive fundraising activities from many individual private donations for the Project; and
- WHEREAS, NHA has been fundraising for the Project based upon those parameters attached hereto as Exhibit A; and
- WHEREAS, the City accepts the updated donor/sponsorship parameters/levels outlined in Exhibit A for purposes of the donation to the Project, and that the same will be implemented by the City for those individual donors at the respective levels of donation and for the durations specified for the respective level of donations specified in Exhibit A, subject to future amendment of the same by the City Council in its discretion with respect to any future donations not covered by this Resolution, and further subject to any separate donation resolution or naming rights agreements between the City and individual donors for the Project or future improvements of the Project, and further subject to NHA providing the City an official list of all such individual donors making up the below donation amount and the respective amount per donor and corresponding donation level pursuant to Exhibit A; and
- WHEREAS, the City, commensurate with this Resolution, shall act on completed naming rights agreements for sponsorship levels of \$100,000 or more for the Project pursuant to separate resolution for such respective naming rights agreements and the same shall not be considered a part of this Resolution; and
- WHEREAS, based in part on the foregoing, the City is willing to undertake the construction of the Project as soon as practicable subject to the requirements of applicable law,

approval by City's City Council of Final Design plans and specifications, bidding, contract(s) award, and completion of financing for the Project; and

WHEREAS, the Donor has raised funds and desires to now donate the same in the amount of \$1,254,369.00 (the "donation") to the City for the exclusive use of the same by the City to pay costs incurred by the City associated with the construction of the Project and future costs associated with the operation and maintenance of the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL THAT:

- 1. The City Council of the City of Northfield hereby accepts the above-described donation for the ice arena project based on the terms and conditions prescribed herein pursuant to Minnesota Statutes, Section 465.03.
- 2. The City Clerk is hereby authorized and directed to issue a receipt to the Donor acknowledging the City's receipt of the donation.
- 3. The City Council on behalf of the City, with great appreciation, wishes to thank the NHA and all of the individual donors for their generous contributions to the donation to the City.
