**2**. 24-586

In person presentation "Getting to know the MN ACLU (American Civil Liberties Union) and overview" by Karla Esqueda, ACLU Organizer.

Karla Esqueda, ACLU organizer, presented information and answered questions from the commissioners about the work of the MN ACLU, highlighting the ACLU's priorities within the immigrant community. She spoke specifically about legal actions the ACLU undertook in Faribault to address discriminatory housing ordinances in violation of the Fair Housing Act, which resulted in civil judgments that changed those ordinances and provided financial compensation to the plaintiffs. She also outlined the importance of

"Know Your Rights" meetings to provide information and promote self-advocacy within the immigrant community.

# 3. 24-587 2024 Fair Housing Month presentation

Emery John, Community Development Intern, presented information about the City of Northfield's Fair Housing Statement, highlighting two recent studies looking at affordability and equity in Northfield from which possible solutions and recommendations can be gleaned and which can be used as a benchmark for measuring fair housing in Northfield moving forward. John emphasized issues within the city regarding housing vouchers and the need for the city to address this.

After taking questions from the commissioners, John encouraged commissioners to attend the upcoming Open Air Open House.
