The bonds are conduit revenue bonds payable solely from revenues of the facility paid directly to lender with no money changing hands through the City. If there is a default on the bonds, it would not affect the City's credit rating or debt limitations. This bond issuance is considered a pass-through to help preserve existing affordable housing.
