THE AWARD

This annual award honors those individuals who have, over a long period of time, made significant contributions to Northfield in, through, or on behalf of arts and culture, so as to enhance the reputation of the city and the quality of life of its residents and visitors.

Culture, as defined in the 2019 Cultural Plan, encompasses the whole of the community's intellectual and social formation, including its work, thoughts, behaviors, and beliefs as manifested through the arts, food, oral languages, dress, homes, recreation, history, landscape, rituals, traditions, celebrations and festivals.

One recipient will be named each year - either a practitioner in one of the arts or a supporter/advocate/arts or cultural leader.

The Living Treasure Award recipient will be honored during the State of the City Address on March 21st, 2023.

DEADLINE FOR SUBMISSION OF NOMINATION FORMS

To be considered for the 2023 Award, nomination forms must be submitted no later than 5 pm, Sunday, October 30th, 2022, and can be submitted online

CRITERIA FOR NOMINATION (taken from the United Nations guidelines to countries, states, and cities):

- The nominee must have amassed a body of work that demonstrates consistency of excellence.
- The nominee must be an inspiration to others.
- Personal admirable attributes that the nominee may possess include: kindness, courage, wisdom, grace, authenticity, humor, humility, respectfulness and generosity.
- The nominee must be living and a Northfield area resident (within school district boundaries).
- The nominee, in discussions with the ACC, is encouraged to serve the community and share his/her expertise for a period of no less than twelve months from March through February during the year after receiving the award, to the extent they are

In addition to the criteria that a nominee must meet to be designated as a Living Treasure, the nomination process has three basic requirements:

1. The nomination must be approved by no less than three persons not related to the nominee.
2. The nominator must inform the nominee about the intent to pursue a nomination, and the nominee must agree to be nominated. ~~All nominees will be publicly recognized at the Living Treasure award ceremony.~~
3. The nominator must work together with the nominee to complete this form.

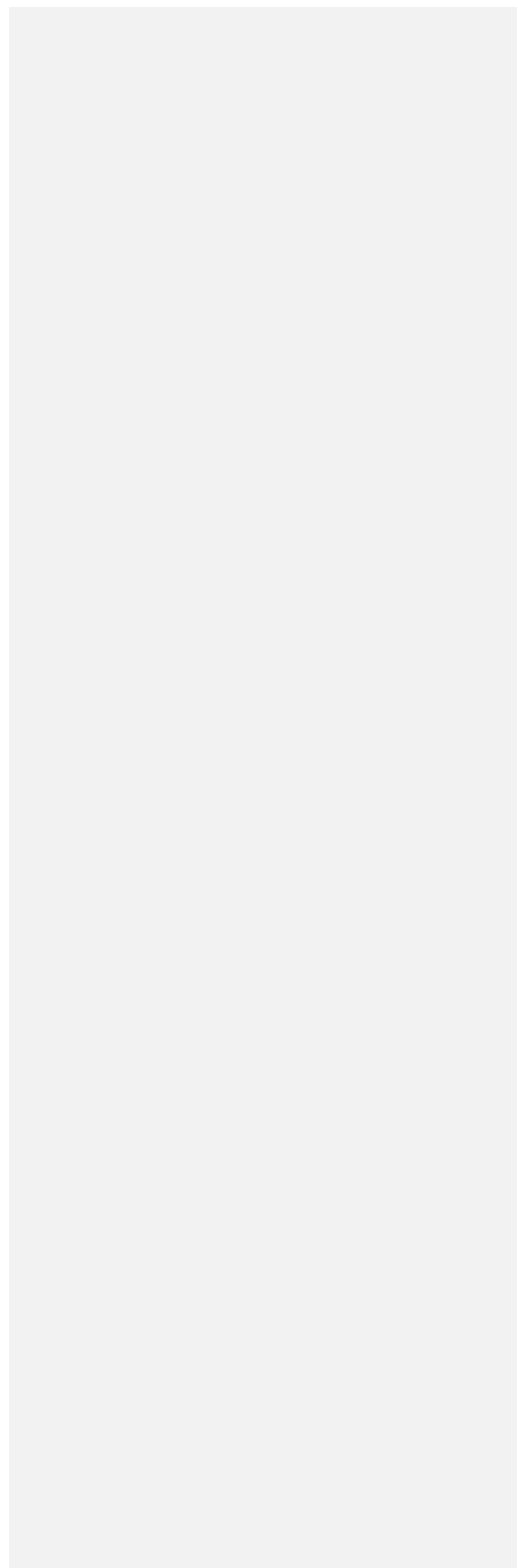
