Discuss Services Related to Expiring Residential Waste Hauling Contract with DSI and Upcoming Proposal Request.

Public Works Director/City Engineer David Bennett introduced the item presenting on the Request for Proposals for the Residential Waste Hauling Contract. Bennett gave an overview of the timeline for the RFP and new contract, review of existing services, Environmental Quality Commission Input, and Housing and Redevelopment Authority steps.

Bennett went through Policy feedback to include bi-weekly recycling; spring cleanup - adding a north site; working with reuse-type vendors to repurpose at spring cleanup; continuation of voluntary yard-waste program; and city-wide organics where residents voluntarily sign up.

Bennett answered questions from the Council.

Jeff Weas, Director of Sales from Dick's Sanitation, addressed the Council regarding their past partnership with the City of Northfield and concerns regarding the upcoming RFP process. Weis answered questions from the Council.

Council provided guidance on the policy questions presented for clarification in the RFP process and questions. Bennett will bring more information to a future meeting regarding organics and the RFP.

Discuss Amendments to Board and Commission Rules of Business and Appendices Related to Remote Participation.

City Administrator Ben Martig introduced amendment discussion for the Board and Commission Rules of Business regarding remote participation. Staff recommendation is to allow remote access for members of the HRA, EDA, PC and HPC due to the powers they are granted and the timelines they may have to meetings to approve applications and other items. Council provided feedback and all were in favor of a trial period of that option. Staff will draft the Board and Commission Rules of Business with this option for approval at the next Council meeting.
