A RESOLUTION BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTHFIELD, MINNESOTA SETTING FEES AND PENALTIES RELATED TO CHAPTER 30 – HEALTH AND SANITATION OF THE CITY CODE, ARTICLE III – REGULATION OF CANNABIS RETAIL BUSINESSES, LOWER-POTENCY HEMP EDIBLE RETAILERS, AND EVENTS

- WHEREAS, on May 6, 2025 the City Council of the City of Northfield adopted Ordinance No.1076 amending Chapter 30 – Health and Sanitation of the City Code adding Article III – Regulation of Cannabis Retail Businesses, Lower-Potency Hemp Edible Retailers, and Events, relating to the regulation and registration of cannabis and hemp retailers within the City of Northfield, and this ordinance in sections 30-127, 30-161, and 30-192 authorizes the City to establish certain fees by resolution for the initial registration and renewal registrations of the same and for temporary cannabis events; and
- WHEREAS, Section 30-105 of Ordinance No. 1076 also provides for the penalties for violations of such ordinance, and the City desires that such penalties be included in the City's fee resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL THAT: the Northfield City Council hereby approves the fees and fines as detailed below to be effective following passage hereof and directs that the same be incorporated into the City of Northfield Fee Schedule:
