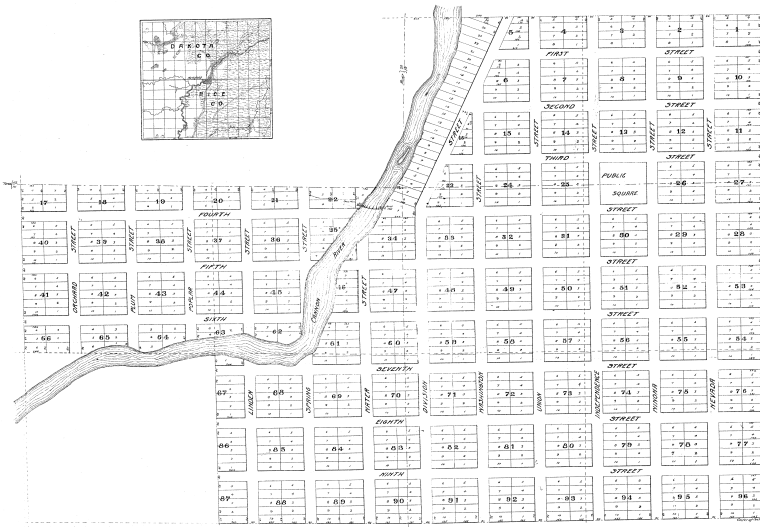


NORTHFIELD RICE COUNTY, MINNESOTA TERTY.

I, **Charles W. Kellogg**, being a licensed Surveyor, hereby certify that on or about the first day of November 1887 I made an accurate survey of the Town of Northfield in the Counties of Rice and Dakota and Territory of Minnesota and that the within is a correct map and plat of the same. That I have caused to be published and filed a good and sufficient return to every acre of the survey of the lands, together with the names of the owners, and that the streets in said Town run East and West North and South and are all eighty feet wide, that said Town is bounded by a line commencing at the North East corner of Section One in Town 44 North of Range 63 West, running thence west one half mile; thence South one fourth of a mile; thence East one fourth of a mile; thence South one fourth of a mile; thence East three fourths of a mile; thence North three fourths of a mile; thence West one half of a mile; thence South one fourth of a mile to the place of beginning. Containing three hundred and sixty acres of land according to the United States survey.
