*Community Development Director Jake Reilly presented on the potential rezoning of the Northwest Area from Agriculture to Industrial. Reilly presented background information on the rezoning, map amendment and text amendments which are written in Ordinance Nos. 1071 and 1072.*

*Reilly indicated the Planning Commission recommendation for the map amendment is for only the smaller area. Staff recommendation is for entire area.*

*Reilly presented on the text amendments including market feasibility, fiscal impact and infrastructure improvement recommendations aligning with Northfield's climate goals of renewable energy. Proposed amendments include limited update to the existing A-S Agriculture, I1-B Industrial; removal of ED-F Economic Development Floating District zone; and additional updates regarding adult-use cannabis.*

*Reilly indicated the Planning Commission recommendation is to remove data processing facilities and any reference to them. Staff recommends retaining the language related to data processing facilities.*

*Reilly answered questions from the Council.*

*Jane Bartho, President of the Northfield Chamber, addressed the Council in support of the language supported by City staff to include data processing facilities.*

*Tom Sorem, 32260 Garrett Avenue, addressed the Council in support of language supported by City staff to include data processing facilities.*

**A motion was made by Council Member Ness, seconded by Council Member Holmes, to approve the first reading of Ordinance No. 1071 Amending Northfield City Code, Chapter 34 - Land Development Code: Article 2. Zoning Districts and Use Regulations, Article 3. Site Development and Article 9. Definitions retaining the language referring to Data Processing Facilities.
