- WHEREAS, the City of Northfield (the "City") entered into the Cannon Commercial Center Subdivision Agreement (the "Subdivision Agreement"), dated June 2, 1999, with Northfield Construction Company, Inc. and Destiny Investment Group, LLC (collectively referred to hereinafter as the "Developer"), relating to certain real property located in the County of Rice, State of Minnesota, described in the Subdivision Agreement as "Final Plat of Cannon Commercial Center to the City of Northfield" (the "Development Property"); and
- WHEREAS, pursuant to the Subdivision Agreement, the Developer substantially and satisfactorily completed the required terms and conditions set forth in the Subdivision Agreement; and
- WHEREAS, the City has now re-platted a portion of the Development Property as Cannon Commercial Center 2<sup>nd</sup> Addition, and the buyer of a portion of the newly platted property, LTJ Investments, LLC, a limited liability company under the laws of the State of Minnesota, has requested that the City release and terminate the above-referenced Subdivision Agreement.

#### NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL THAT:
