**NOTICE IS HEREBY GIVEN**, that the City of Northfield City Council will conduct a public hearing in the Council Chambers at Northfield City Hall, 801 Washington St., Northfield, MN, on Tuesday, April 1, 2025, beginning on or after 6:00 p.m. to receive public input to consider Central Park as a local heritage preservation site. The property is located at 421 4<sup>th</sup> St E.


