## Climate Action Plan Outline

This outline frames the bulk of the Northfield Climate Action Plan. The topic areas were created from the basic needs of Northfield residents. Each topic area will then include elements that are cross sectional for all topic areas within the plan.

### Indicators of a Sustainable Community:

- **Economic health** for a local and prosperous economy
- **Physical health** for healthy and active residents of all ages
- **Environmental health** for clean air, water, and land
- **Quality of life** for all

### Climate Action Plan Topic Areas:

- Energy
- Land
- Transportation
- Materials & Waste
- Water, Stormwater, & Wastewater
- Food

### Elements for each Topic Area:

- **Municipal, commercial, residential, and industrial goals and action steps:** Each of these areas are unique and will need their own set of goals and action items.
- **Carbon Reduction Goal:** Current emission sources, targets, and an ultimate reduction goal.
- **Emergency Response and Resilience Plan:** Hope for the best, plan for the worst.
- **Funding:** What are the expenses for achieving the carbon reduction goals and identify possible funding sources for each expense.
- **Education and Outreach Campaigns:** How will this information be spread? How to we create aware citizens and guests to Northfield?
- **Implementation and Action Steps:** Who needs to be involved? What groups or organizations? How to keep the work going beyond writing the CAP?

## CAPAB Timeline

This timeline comes from the City’s Climate Change Impacts section of the Strategic Plan and is combined with the CAPAB Co-Chairs timeline to make the deadlines set forth in the Strategic Plan.

## CAPAB Progress to Date:

### Quick Hits

The CAPAB has a strong sense of urgency to halt Northfield's impact on a changing climate. The "Quick Hits" list was created and designed to allow these action items to work parallel to the CAP planning and drafting. More information on specific Quick Hits is on page 9.

### Survey

The CAPAB felt it was necessary to hear from Northfield Residents *before* drafting a CAP. The survey was designed to hear where residents think Northfield should focus its time, as well as what strategies residents know the most about. This information will help frame our educational conversations as the CAP develops. The survey was conducted over the month of October with over 1,000 responses to the survey. Key takeaways are as follows, for a full report, please visit the City's CAPAB website.

- Over 80% of respondents are supportive of the city taking action to reduce climate change impacts.
- Respondents stated that they would like much more information about individual and collective actions to reduce greenhouse gas emissions and how to adapt to climate change.

### CAP Consultant- Great Plains Institute

Great Plains Institute has been working with LHB Associates and the City to gather baseline data to measure the carbon impact of the community. The consultants also worked with the co-chairs to develop a worksheet to extract information from each working team (land, transportation, etc.) in preparation for an all-team working session in February.

### Working Teams

Each topic area of the Climate Action Plan has its own working group and meets outside of the CAPAB meetings, see page 11 for the full calendar. These teams are lead by a member of the CAPAB and are comprised of other CAPAB members, residents, and local experts in each topic area. Page 7 has an updated set of working priority areas for each team.

## Summary of Climate Action Plan Priority Areas

The CAPAB is hard at work and has accomplished much in a short time and is on target with the timeline laid out in the City's Strategic Plan. Working teams have been meeting regularly and have each identified priority areas for the CAP:

### Food:

- Expand food recovery, education and promote composting food waste and individuals food carbon footprint
- Create a community wide response in support of our local farms when extreme weather hits
- Create sustainable growing of food on city land and educate and create the storage of food

### Materials & Waste:

- Divert overall waste going to the landfill
- Educate Northfield residents and visitors about waste and how to reduce it
- Policy at the city level to incentivize waste reduction and circular economies

### Water, Wastewater & Storm Water:

- Open city planning - ensure that our findings are built into the City's planning, zoning and staffing processes to ensure long term resilience
- Identify the limitations on water and how to evaluate projects against the limits we have on potable, waste and storm waters
- Provide a framework for evaluating mitigation, conservation and recovery efforts

### Energy:

- Vision of "energy for all"
- Energy conservation strategies by sector (municipal, industrial, institutional, commercial, residential)
- Renewable energy strategies by sector
- Resilience planning by sector
- Intersections with codes and city planning
- The future of the public grid

## Summary of Climate Action Plan Priority Areas (Continued)

### Land:

- Natural carbon solutions through biological sources
- Built environment best practices
- Health of community related to shade, air quality, and temperature

### Transportation:

- Reduce greenhouse gas emissions by reducing vehicle miles traveled through integrated land use and transportation solutions
- Increase bicycle and pedestrian transportation
- Increase the use of public transit systems
- Increase employee commuter options
- Embrace electric vehicles, alternative fuel vehicles, and other emerging technologies



## Climate Action Quick Hits

The list below should be considered a working document that will continue to grow and evolve over time. **Bolded** actions are current priorities. Many items have now shifted responsibility to the consultant, the Great Plains Institute.

### Quick hits are intended to achieve one or more of the following:

- Demonstrate immediate tangible action
- Build community support, excitement, and momentum
- Address “low hanging fruit”

### Quick hits should:

- Be low or no cost
- Engage little to no political adversity
- Require minimal time commitment to be easy and clear to delegate
- Be flexible and fresh

- Research and Information Exchange
- Outreach & Community Building
- Resilience Building and Carbon/Waste Reduction
- Parking Lot Ideas or Other
