RE: 8115 Engine Replacement Recommendation

Dear Ms. Haddad-

On September 10, 2018, the Northfield Area Fire and Rescue (NAFRS) Truck Committee opened quotes for the 8115 Engine Replacement. There were two bids received for the engine replacement project, which have been tabulated, reviewed, and are enclosed with this letter.

Custom Fire Apparatus, Inc. is the apparent lowest quote on the project with a lump sum base price quote of \$622,038.00. Quotes were submitted requesting a discount for a \$400,000 pre-pay by December 1, 2018. If the NAFRS board chooses to pursue the pre-pay option, a discount of \$14,200.00 will be applied to the lump sum base price, for a final lump sum price of \$607,638.00. This final price would be under the \$620,000.00 budget approved by the NAFRS Board.

The NAFRS Truck Committee recommends the NAFRS Board accept the quote from Custom Fire Apparatus, Inc. Aside from being the lowest quote for the project, NAFRS has had a longstanding positive working relationship with Custom Fire Apparatus, Inc. and the familiarity of their equipment and apparatus operation is key in efficient training and operation for all of our NAFRS members.

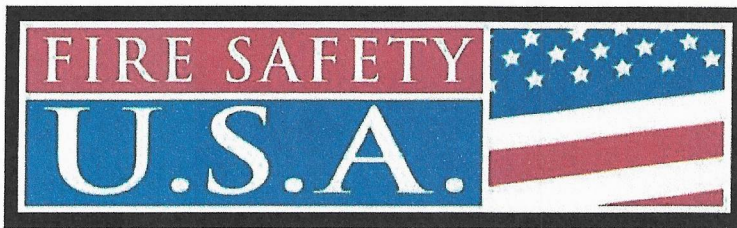
