2018 DIVISION AND SEVENTH STREET RECONSTRUCTION,  
WASHINGTON STREET MILL AND OVERLAY,  
AND VARIOUS CITY PARKING LOTS  
APPROVING PLANS AND SPECIFICATIONS AND  
AUTHORIZING ADVERTISEMENT FOR BIDS  
PROJECT STRT2018-A37

WHEREAS, pursuant to Resolution 2017-097 passed by the City Council on October 17, 2017, city staff has prepared plans and specifications for 2018 Improvement No. A37 – 2018 Division and Seventh Street Reconstruction, Washington Street Mill and Overlay, and Various City Parking Lots; and, has presented such plans and specifications to the Council for approval; and,

WHEREAS, the following streets are a part of 2018 Improvement No. A37:

- Division Street from Eight Street to Sixth Street (Reconstruction)
- Seventh Street from Water Street to Washington Street (Reconstruction)
- Washington Street from Woodley Street to Second Street (Mill and Overlay)
- City Hall Parking Lot ( Mill and Overlay)
- Washington Street and Fifth Street Parking Lot (Mill and Overlay)
- Washington Street Parking Lot 1 (Third Street Lot – Reclamation)
- Washington Street Parking Lot 2 (Grand Event Center – Pavement and subgrade reconstruction)

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL THAT:

1. Such plans and specifications, copies of which are available on the City of Northfield’s website, are hereby approved.
2. The City Clerk shall prepare and cause to be inserted in the official paper, Northfield News, and on the MnDOT e-Advert website, an advertisement for bids upon the making of such improvement under such approved plans and specifications. The advertisement shall be published for 21 days, shall specify the work to be done, shall state that bids, will be received by the City Clerk until 2:00 p.m. on April 5, 2018, at which time they will be publicly opened in the Council Chambers of the City Hall by the City Clerk and the City Engineer, will then be tabulated, and will be considered by the Council at 6:00 p.m. on April 17, 2018, in the Council Chambers of the City Hall. Any bidder whose responsibility is questioned during consideration of the bid will be given an opportunity to address the Council on the issue of responsibility. No bids will be considered unless sealed and filed with the Clerk and accompanied by a cash deposit, cashier’s check, bid bond or certified check payable to the Clerk for five percent (5%) of the amount of such bid.
