City Clerk Lynette Peterson presented background information on the Froggz Liquor License stating the City was notified on November 3, 2025 that the liquor liability insurance had lapsed for the establishment. Liquor liability insurance is required by City Code and State Statute therefore immediate suspension of Froggz's license is necessary until proof of insurance is obtained and confirmed from the licensee.
