- The timing of getting information packets on, the formatting of, and the process of reviewing Certificates of Appropriateness.
- Reviewing and proposing revisions on, clarifications of, and amendments to City policies, guidelines, and the Land Development Code on the building and renovation of properties in the Downtown Historic District or historical residential areas, including riverfront enhancements, balconies, solar panels, and murals.
- Creating subcommittees to review and work on these issues. Commissioners Meehan and Beimers expressed interest in reviewing balconies, solar panels, and murals.
- Developing walking tours of the Downtown Historic District and reviewing existing educational materials.
- Reviewing local designation of historic homes and neighborhoods.
- Applying for Certified Local Government grants to fund planning and review projects.
