21. 25-460 City Administrator Update

I am very excited to share the attached final bond sale results for the ice arena. As noted in the summary, the lowest indicated interest rate is 4.3%, which is .71% lower than pre-sale estimates. The results show a \$120,995 reduction to the average annual debt service cost from the presale estimates, which accumulates to over **\$2.4 million less** in total principal and interest reduction to the City of Northfield and City of Dundas planned annual contribution amounts. The City of Dundas annual contribution is reduced to \$189,313 (a \$14,719 reduction) and respectively the City of Northfield's annual contribution is reduced to \$1,370,671 (a \$108,276 reduction).

The last page does include the debt service and lease contribution schedule. As outlined on that page, \$200,000 of the school lease contribution for the new arena is to be allocated internally by the City to this debt retirement. This is in addition to the \$50,000 of the school lease arrangement that is to be allocated internally by the City to the arena operational budget.
