CITY COUNCIL RESOLUTION 2020-009  
APPROVING PLANS AND SPECIFICATIONS AND  
AUTHORIZING ADVERTISEMENT FOR BIDS  
2020 MILL AND OVERLAY  
PROJECT STRT2020-A45

WHEREAS, pursuant to Resolution 2019-119 passed by the City Council on November 5, 2019 city staff has prepared plans and specifications for 2020 Improvement No. A45 – 2020 Mill and Overlay Project; and, has presented such plans and specifications to the Council for approval; and,

WHEREAS, the following streets are included in the 2020 Improvement No. A45:

- a. First Street – College Street to Maple Street including bumpouts at Winona Street and Nevada Street with bumpouts on both the east and west side of First Street
- b. Second Street – Washington Street to Oak Street including sharrows
- c. Third Street – Washington Street to Oak Street
- d. Fourth Street – Nevada Street to Prairie Street including bike cycletrack
- e. Union Street – First Street to Second Street
- f. College Street – First Street to Third Street including bike cycletrack
- g. Winona Street – First Street to Fourth Street
- h. Nevada Street – First Street to Fourth Street including on-street bike lanes
- i. Maple Street – First Street to Fourth Street
- j. Elm Street – Second Street to Fifth Street
- k. Oak Street – Second Street to Fourth Street
- l. Heritage Drive – TH 3 to Hidden Valley Apartments including bike cycletrack
- m. Jefferson Road – Hidden Valley Road to Heritage Drive including bike lane and shared parking/bike lane.
- n. Seventh Street – Water Street to West dead end including bumpouts on both the east and west side of Water Street.
- o. Eight Street – Water Street to Linden Street including on-street bike lanes.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL THAT:

1. Such plans and specifications, copies of which are available on the City of Northfield’s website, are hereby approved.
2. The City Clerk shall prepare and cause to be inserted in the official paper, Northfield News, and on the MnDOT e-Advert website, an advertisement for bids upon the making of such improvement under such approved plans and specifications. The advertisement shall be published for 21 days, shall specify the work to be done, shall state that bids will be received by the clerk until 2:00 p.m. on February 20, 2020 at which time they will be publicly opened in the Council Chambers of the City Hall by the City Clerk and City Engineer, will then be tabulated, and will be considered by the Council at 6:00 p.m. on March 10, 2020, in the Council Chambers of the City Hall. Any bidder whose responsibility is questioned during consideration of the bid will be given an opportunity to address the Council on the issue of responsibility. No bids will be considered unless sealed and filed with the Clerk and accompanied by a cash deposit, cashier’s check, bid bond or certified check payable to the Clerk for five percent (5%) of the amount of such bid.
