17. <u>Res. 2025-059</u> Consider Resolution Requesting State Capital Investment Bonds for Water Treatment Plant in the City of Northfield.

City Administrator Ben Martig introduced the item giving an update on the Capital Bonding Requirements. Utilities Manager Justin Wagner explained the design of the Water Treatment Plant with this request only looking at the gravity filtration water treatment plant to remove manganese. Martig, Public Works Director/City Engineer David Bennett and Wagner answered questions from the Council.

After discussion regarding the request, the Council agreed they would like to see a pause on the project and not request the funding at this time. The Council directed staff to research costs for providing water to the residents with a possible small scale reverse osmosis water filling system providing self-service water dispensers/refill stations at the Northfield Community Resource Center and the Northfield Community Education Center. Costs of this option will be brought back to Council for consideration at a future work session or council meeting. A couple of Council Members would also like to explore the option of offering free water testing for infant households in the City. A motion was made by Council Member Holmes, seconded by Council Member Sokup, to approve Resolution No. 2025-059 Requesting Minnesota State Capital Investment Bonds for Water Treatment Plant in the City of Northfield with Priority #1 Designation. The motion failed by the following vote:
