2 - 2025 Work Plan Consideration

The EQC discussed possible initiatives for the 2025 Work Plan that were collected by City Staff in the 2025 Work Plan Submissions for Consideration document. Specific ideas that emerged were:

- Native plantings, incentives for the use of electric yard maintenance implements and water conservation in landscaping. Commissioner Shmurak would be interested in leading this initiative.
- Urban forestry, including retention or improvement of the City's tree canopy.
- Commissioner Mattson invited her Carleton College colleague Rob Hanson of 915 2nd Street West to the podium, and both of them spoke on the possibility of the EQC encouraging new building projects that receive city funding to exceed current sustainable building guidelines.
- Commissioner Petri wants to continue her outreach efforts to promote home energy efficiency improvement incentives, including possible grants and rebated that might be part of the Inflation Reduction Act.
- Commissioner Shmurak is interested in promoting existing energy efficiency incentives via social media and local media.
- Several members of the EQC are interested in promoting the adoption of heat pumps by homeowners.
- Continuation of the reduction of plastic waste initiative.
- Encouragement of disaster and emergency preparedness including households having enough food and water available to them.
- Improving local transportation infrastructure such as public transportation and installations of electric vehicle chargers.
- Continued exploration of city-wide curbside composting options.

Assistant to the City Administrator Risi Karim provided context and information on existing and future city initiatives.
