New 3-stream trash bins have been delivered to City Hall and the Library. Commissioner Kinney suggested the Carleton CCCE students could help with this roll out. Commissioner Provancha has met with Kinney to further work on this initiative.

- Karim provided an update on the Inflation Reduction Act Public Forum scheduled for November 2, 2023. The event is shaping up nicely with panelists and a contractor confirmed and the flyer out in the public. Chair Petri encouraged all homeowners to attend. Commissioner Provancha informed the Commission on some of the difficulties in having local contractors participate

- Commissioner Jones has received comments on the Urban Forestry Management draft report. Jones and Commissioner Kinney expect to deliver a new draft to the EQC in November.

- Karim is working on the Climate Action Plan Update which will be delivered, along with an Xcel Energy Partners in Energy update, at the Energy Open House next week on October 25, 2023. All commissioners are asked to attend the event.

- Karim reported that the Green Welcome Packet is available in the hallway of City Hall and is being distributed widely.

- On the topic of Energy Action Items, Karim reported that the Energy Open House is next week on October 25, 2023. The District Energy System study group will be touring Post facilities on October 19, 2023. The participation of Post will be essential to the future of this project. Commissioners provided comments on the project and Karim responded to their questions.

- Karim reminded the Commission that the EQC Annual Work Plan process will begin in November 2023.
