Existing Service Contract

- Contract Began in 2013 and expire March 31, 2019
- Collection is for single family, and multi-family/apartments up to 6 units.
- Contract allows for collection of
 - Garbage & Refuse (Weekly Collection 35 Gal, 65 Gal, 96 Gal Carts)
 - Recyclable (Bi-Weekly Collection)
 - Organic Food/Wet Waste trial (could be implemented)
 - Yard Waste & Brush Collection (April 1 – May 15 Spring & Oct 1 – Nov 15 Fall)
 - Christmas Tree Collection
 - White Goods and Electronics Collection
 - Spring Clean-up Days – Two Saturdays



Existing Service Contract DSI Programs

- Enviro Education Center (website with waste deposits info.)
- Schedule Reminder Center (Automated dialer reminds residents of holiday schedule)
- Reduction Tactics Initiative
 - Paperless routing
 - Alternative fleet fuels
 - Paperless invoicing
- Enviro-fact reporting
- Treewards Program
- Hauler Scholars Program
- DSICycleback Program – share portion of residential recycling reimbursement from Rice County
- DSI recycling roll-off – proceeds to local youth organizations

Proposed Contract Changes

- Recommendation from Environmental Quality Commission
 - Work with City to Develop Outreach Program
 - Provide additional annual data regarding Northfields Waste Stream
 - Keep language regarding curbside composting
 - Other Considerations
 - Big Sweep Alternative - Carted Yard Waste Collection Spring – Fall (min. 200 Residents need to side up)
 - Alleviates concerns w/resident pushing leaves into street creating hazard and flooding concerns
 - Currently White Good Prices are Charged on the two Saturday spring cleanup (consider lower price structure – match rice county landfill rates)
 - Pay by weight
 - DSI fleet not equipped
 - Constant calibration of weighing equipment
 - Would need scanner bar system by bin or GPS
 - DSI Mobile Education Trailer
