**16.** Res. 2025-072 Consider Resolution Providing for the Issuance and Sale of \$4,440,000 General Obligation Street Reconstruction and Equipment Bonds, Series 2025A.

Nick Ahnut, Senior Financial Advisor with Ehlers and Associates, presented on the sale of \$4,440,000 General Obligation Street and Equipment Bonds, Series 2025A. The bond sale includes \$4,025,000 Street Reconstruction Plan Bonds for the Wall Street/2025 Reconstruction and \$415,000 Equipment Certificates for the City's share of the NAFRS tanker. Anhut stated Standard and Poors affirmed the City's "AA" credit rating. The City received four bids with the low bidder being Brownstone Investment Group, LLC at 3.9434%. Anhut indicated an updated resolution was presented to the Council with the amount reduced to \$4,115,000 with a true interest cost of 3.9667%.

A motion was made by Council Member Ness, seconded by Council Member Peterson White, to approve Resolution No. 2025-072 Awarding the Sale of \$4,115,000 General Obligation Street and Equipment Bonds, Series 2025A. The motion carried by the following vote:

Consider Approval of Relocating the Archery Range to Meadows Park.

Public Works Director/City Engineer David Bennett introduced the item giving background information on the relocation of the Archery Range to Meadows Park. Due to the construction of Jefferson Parkway east of Spring Creek Road, the extension of the roadway will impact the Archery Range, requiring it to be relocated.

Consider Resolution Receiving Charter Amendment to Section 3.5 of the City Charter and Calling for a Public Hearing on Charter Amendment Proposed to be Adopted by Ordinance.

Charter Commission Chair Lance Heisler addressed the Council giving background on the City Charter 3.5 amendments with regard to vacancies in the Council or in the Office of the Mayor. Language has been clarified as prior language may have caused confusion regarding the process as it relates to filling vacancies on the City Council in a year in which a regular election for one or more city council seats is pending. This updated language will close the gap between the election and when the individual begins serving. The language also indicates ballots will contain information as to the term being filled.

A motion was made by Council Member Holmes, seconded by Council Member Beumer, to approve Resolution No. 2025-073 Receiving Charter Amendments and Calling for a Public Hearing on Charter Amendments Proposed to be Adopted by Ordinance. The motion carried by the following vote:

Associate City Planner Mathias Hughey presented background information on the Conditional Use Permit Application for St. Olaf Collect to add 26 parking stalls to the

Lincoln Street Parking lot within the Perimeter Transition Area. Staff recommendation is to deny the CUP.

Hughey answered questions from the Council.

Mike Berthlesen, Applicant from St. Olaf College, addressed the Council regarding the CUP explaining the reason for additional spaces.

Community Development Director Jake Reilly added additional details on the motion stating a reason for approval or denial of the application needs to be stated in the motion.

Community Development staff will bring an approval resolution stating the criteria for approval to the August 4, 2025 Council Meeting Consent Agenda.

A motion was made by Council Member Peterson White, seconded by Council Member Beumer, to approve the conditional use permit based on finding that because the additional parking proposed by the applicant is within the perimeter of an existing parking lot, that the findings related to a change in the neighborhood character or an effect on the neighborhood character are not accurate in this setting.
