CITY COUNCIL RESOLUTION 2025-045
APPROVING PLANS AND SPECIFICATIONS AND
AUTHORIZING ADVERTISEMENT FOR BIDS
MILL TOWNS STATE TRAIL
WOODLEY STREET TO WATERFORD BRIDGE PROJECT
PROJECT PARK2023-F16

- WHEREAS, the City of Northfield on April 16, 2019 adopted its Pedestrian, Bike, and Trail System Plan; and,
- WHEREAS, the City of Northfield, as part of the adopted Pedestrian, Bike, and Trail System Plan, has identified the planned route of Mill Towns State Trail through Northfield in the Plan; and,
- WHEREAS, the City of Northfield and Minnesota Department of Natural Resources entered into a preliminary design cooperative agreement 222089 for the Mill Towns State Trail from Riverside Park in Northfield to the Waterford Bridge on September 3, 2019; and,
- WHEREAS, the City of Northfield and Minnesota Department of Natural Resources completed the preliminary design Mill Towns State Trail from Riverside Park in Northfield to the Waterford Bridge on October 5, 2021; and,
- WHEREAS, the City of Northfield and Minnesota Department of Natural Resources amended the preliminary design cooperative agreement to include the final design for the Mill Towns State Trail from Northfield to the Waterford Bridge on December 6, 2022; and,
- WHEREAS, the final design is complete, and plans and specifications are ready for bid.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL THAT:

1. Such plans and specifications, copies of which are available on the City of Northfield's website, are hereby approved.
2. The City Clerk shall prepare and cause to be inserted in the official paper, Northfield News, and on the QuestCDN, an advertisement for bids upon the making of such improvement under such approved plans and specifications. The advertisement shall be published for 21 days, shall specify the work to be done, shall state that bids will be received by the clerk until 2:00 p.m. on June 5, 2025 at which time they will be publicly opened by the City Engineer, will then be tabulated, and will be considered by the Council at 6:00 p.m. on June 17, 2025, in the Council Chambers of the City Hall. Any bidder whose responsibility is questioned during consideration of the bid will be given an opportunity to address the Council on the issue of responsibility. No bids will be considered unless sealed and filed with the Clerk and accompanied by a cash deposit, cashier's check, bid bond or certified check payable to the Clerk for five percent (5%) of the amount of such bid.
