City Planner Mikayla Schmidt introduced stakeholder input collected on the Bridge Square park renovation project. Commissioners discussed logistics and feasibility of the park design toward hosting major events and attractions. They also expressed interest in seeing a version of the plan designed to depict a stage, vendors, and traffic flows during varied iconic Northfield events like Vintage Band Festival, Riverwalk Market Fair, and Defeat of Jesse James Days. They directed Schmidt to prepare such language for recommendations to the planner.

Chair Buckheit invited Assistant City Planner Revee Needham to introduce herself. Needham described ways to measure zoning considerations of parking and parking/structure ratios and considered how to use Land Development Code language defining parking space, pavement, and porches for promoting construction. Needham helped Commissioners define difference between terms "lot coverage," "Floor Area Ratio," and "Building Area Ratio." Commissioners discussed the goals of the Code and how to measure its efficacy of goal achievement per updated goals like those of the Comprehensive Plan or Climate Action Plan. Commissioners requested staff to provide wide-ranging information in a variety of formats.
