It has already been vetted and appraised. The seller would like a down payment and will accept monthly payments until the full \$12,000 amount is met.

The impact of this assistance means that I can make a larger up-front payment and get the printer sooner than I would be able to manage alone. Since this is a different income stream, this would open up a new product line for us and allow us to offer custom, short run, and limited run apparel in our shop.

The impact will be evaluated by increased sales and whether other artists are interested in working with us to use the printer to make apparel. This is also an opportunity to reduce waste because we are getting a printer second hand and are planning to print on used, vintage, dead stock, or second hand fabrics. We will be able to evaluate the impact of up-cycling based on how many products sell that were given a second life.
