**JOINT RESOLUTION REQUESTING CONCURRENT DETACHMENT FROM
THE CITY OF NORTHFIELD AND ANNEXATION TO THE CITY OF DUNDAS
OF CERTAIN LAND PURSUANT TO MINNESOTA STATUTES SECTION 414.061**

WHEREAS, Johnson-Reiland Builders and Remodelers, Inc., (“Owners”) are the owners of the following legally described property (“Property”) within the City of Northfield:

That part of Lot 1, Block 2, BRIDGEWATER COMMONS, Rice County, Minnesota described as follows: Beginning at the most southwesterly corner of said Lot 1; thence North 89 degrees 59 minutes 38 seconds East, along the South line of said Lot 1, a distance of 195.22 feet to the southeast corner of said Lot 1, thence North 42 degrees 14 minutes 34 seconds East, along the southeasterly line of said Lot 1, a distance of 44.70 feet; thence North 50 degrees 37 minutes 08 seconds West a distance of 223.86 feet to the northwesterly line of said Lot 1; thence South 3.9 degrees 56 minutes 27 seconds West; along said northwesterly line, a distance of 84.18 feet to the northwesterly corner of said Lot 1; thence South 00 degrees 56 minutes 01 seconds East, along the westerly line of said Lot 1, a distance of 110.62 feet to the point of beginning; and

WHEREAS, the Owner owns additional property adjacent to the Property and is seeking approval of a new plat, to be known as Dundas Commons, within the City of Dundas; and

WHEREAS, the Owners have asked the City of Northfield and the City of Dundas, to take action to place their entire property into the city boundaries of Dundas; and

WHEREAS, the City Council of Northfield and the City Council of Dundas have each concurrently determined that detachment of the Property from the City of Northfield and annexation of the Property to the City of Dundas would be in the best interests of the Owners and the respective cities and that such detachment and annexation take place without delay; and

WHEREAS, the City of Northfield, the City of Dundas, and the Owners have no objection to the property being located within the corporate limits of the City of Dundas, and have no objections to a modification of these respective municipal boundaries to allow the annexed property to be located in the City of Dundas, and

WHEREAS, to modify such boundaries, the City of Northfield desires to detach, and the City of Dundas desires to annex, said Property pursuant Minnesota Statute 414.061; and

NOW THEREFORE BE IT RESOLVED, that the Cities of Northfield and the City of Dundas jointly request the Office of Administrative Hearings, Municipal Boundary Adjustment Unit concurrently detach the Property from the City of Northfield and annex the same, Property, into the City of Dundas at the earliest practical date. The City Administrator/Clerk for the City of Dundas is authorized to submit this Joint Resolution together with any appropriate application materials to the Minnesota Office of Administrative Hearings, Municipal Boundary Adjustment Unit for the purposes set forth above.

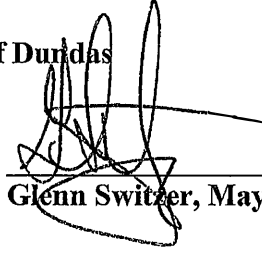

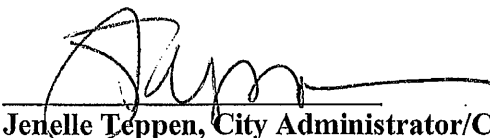
