CITY COUNCIL RESOLUTION NO. 2022-093

A RESOLUTION BY THE MAYOR AND CITY COUNCIL OF THE CITY OF
NORTHFIELD, MINNESOTA SETTING FEES AND PENALTIES RELATED TO CHAPTER
30 – HEALTH AND SANITATION OF THE CITY CODE, ARTICLE III – SALE OF EDIBLE
CANNABINOID PRODUCTS

WHEREAS, on September 20, 2022 the City Council of the City of Northfield adopted Ordinance No. 1044 amending Chapter 30 – Health and Sanitation of the City Code adding Article III – Sale of Edible Cannabinoid Products, relating to the licensing and regulation of the sale of edible cannabinoid products within the City of Northfield, and this ordinance in section 30-120 and 30-121 authorizes the City to establish certain fees by resolution for the licensing, administration, investigation and implementation of the same; and

WHEREAS, Section 30-103 of Ordinance No. 1044 also provides for the penalties for violations of such ordinance shall be as provided in sections 30-27 and 30-28, and the City desires that such penalties be included in the City’s fee resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL THAT:
the Northfield City Council hereby approves the fees and fines as detailed below to be effective following passage hereof and directs that the same be incorporated into the City of Northfield Fee Schedule:

| 3 rd offense within 3 years* | \$2,000.00 civil penalty and 18 day suspension of license |
| 4 th offense within 5 years* | \$2,500.00 civil penalty and revocation of license for a minimum of 1 year |

* measured from date of first offense

BE IT FURTHER RESOLVED by the City Council of the City of Northfield, Minnesota, that the City Clerk be authorized to make the changes to the City’s established fee schedule referenced in this Resolution.
