City Administrator Martig introduced this item, giving background information and indicating that Meleah Follen, Healthy Community Initiative Youth Engagement and

Northfield Community College Collaborative Director, and Mar Valdecantos, former member of the HRC, will speak to this item.

Mar Valdecantos discussed the attached document, dated November 21, 2022, they prepared for the City Council and the Northfield Human Rights Commission on voting rights for youth and adult members on boards and commissions and the recruitment process for boards and commissions.

Maleah Follen, who recruits youth members for boards and commissions through HCI, discussed reasons why not all youth are voting members, relating in particular to the impact on quorums, and further discussed the training youth members are given for active participation on boards and commissions.

Martig discussed statutory requirements and restrictions for youth voting and further discussed Charter City vs. Statutory City and requirements of the City Charter. Martig indicated various actions the HRC could take regarding this issue, including inviting the Mayor to attend the next meeting. In addition, the City Council continues to update the governance of City boards and commissions.

Commission members provided their perspectives on these issues. Valdecantos, Follen and Martig addressed comments and questions from commission members.

Motion by Commissioner Autonoe, second by Youth Representative George, to continue discussion of this item at the next meeting and to request that Mayor Pownell attend to provide additional information. Motion carried by the following vote:
