CITY COUNCIL RESOLUTION 2024-004  
ACCEPTING BIDS AND AWARDING CONTRACT  
HONEYLOCUST DRIVE EAST CANNON RIVER TRAIL (ECRT) PROJECT  
(STRT2021-A56)

- WHEREAS, pursuant to an advertisement for bids for the improvements to the Honeylocust Drive ECRT Project; bids were received, opened and tabulated according to law complying with the advertisement; and,
- WHEREAS, it appears that Fitzgerald Excavating and Trucking Inc. is the lowest responsible bidder with a total Base Bid amount of \$197,259.45; and,
- WHEREAS, it appears that Fitzgerald Excavating and Trucking Inc. is the lowest responsible bidder with a total Alternate #1 bid amount of \$94,355.75; and,
- WHEREAS, it appears that Fitzgerald Excavating and Trucking Inc. is the lowest responsible bidder with a total Base Bid and Alternate #1 bid amount of \$291,615.20

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL THAT:

1. The bid of Fitzgerald Excavating and Trucking Inc, Goodhue, Minnesota, in the amount of \$291,615.20 for the Base Bid and Alternate #1 construction of said improvements in accordance with the plans and specifications and advertisement for bids is the lowest responsible bid and shall be and hereby is accepted.
2. The Mayor and City Clerk are hereby authorized and directed to enter into a contract with Fitzgerald Excavating and Trucking Inc, Goodhue, Minnesota in the name of the City of Northfield for the construction of STRT2021-A56, Honeylocust Drive ECRT Project, according to the plans and specifications therefore approved by the City Council and on file in the office of the City Clerk.
3. The City Clerk is hereby authorized and directed to return forthwith to all bidders the deposits made with their bids, except that the deposits of the successful bidder and the next lowest bidder shall be retained until a contract has been signed.
4. The Mayor and City Council authorize the finance director to transfer \$3,208 to the Arts and Culture Fund for the 1% for public art as follows:
  - a. Capital Fund Reserve transfer \$2,070 to Arts and Culture Fund
  - b. Storm Fund transfer \$1,138 to Arts and Culture Fund
