The commission discussed the proposed amendment to its bylaws regarding appointments of HPC members since it is in conflict with the City Charter. J. Menard reported he and Cliff Clark met with Mayor Pownell to interpret Cliff's appointment by the Northfield Historical Society and she made it clear that she wanted to follow the Charter.

Dave Shumway, First National Bank, spoke to the commission regarding damage done to the main entrance door of the bank. They are proposing metal doors to be painted the same color along with repairs to sections of the granite adjacent to the door.

The HPC spoke in favor of the metal doors but noted the design guidelines require they be coated with a baked enamel finish. D. Shumway stated he will check with the distributor on this requirement prior to purchasing the doors.
