RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION
OF AN AMENDED AND RESTATED TAX INCREMENT PLEDGE AGREEMENT
FOR THE \$465,000 TAXABLE GENERAL OBLIGATION TAX
INCREMENT REFUNDING BONDS, SERIES 2017B
OF THE CITY OF NORTHFIELD, MINNESOTA

WHEREAS, the City of Northfield, Minnesota (the "City") and the Northfield Housing and Redevelopment Authority, Minnesota (the "HRA") have duly established Housing and Redevelopment Project No. 1 (the "Redevelopment Project") pursuant to Minnesota Statutes, Sections 469.001 through 469.047.

WHEREAS, the City and the HRA have duly established Presidential Commons Tax Increment District (TIF District 1-1) (the "TIF District") within the Redevelopment Project pursuant to Minnesota Statutes, Sections 469.174 through 469.1794 (the "TIF Act").

WHEREAS, on November 7, 2007, the City issued its Taxable General Obligation Tax Increment Refunding Bonds, Series 2007D (the "Series 2007D Bonds"), dated November 7, 2007, in the original aggregate principal amount of \$960,000, of which \$435,000 in principal amount is currently outstanding. The proceeds of the Series 2007D Bonds were used to refund the City's General Obligation Taxable Tax Increment Bonds, Series 1999C (the "Series 1999C Bonds"), dated August 1, 1999, issued in the original aggregate principal amount of \$1,050,000. Proceeds of the Series 1999C Bonds were used to finance the redevelopment costs within the TIF District; and

WHEREAS, the City, has awarded or is expected to award the sale of its \$465,000 Taxable General Obligation Tax Increment Refunding Bonds, Series 2017B, dated September 7, 2017 (the "Bonds"), to refund the outstanding Series 2007D Bonds;

WHEREAS, the HRA has agreed to pledge certain tax increment revenues of the TIF District to the City to pay the principal and interest on the Bonds

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Commissioners of the Northfield Housing and Redevelopment Authority (the "HRA") as follows:

- 1. The Amended and Restated Tax Increment Pledge Agreement in substantially the form on file in City Hall is hereby approved, and the duly authorized officers of the HRA are hereby authorized and directed to take such steps as may be necessary to execute said Agreement, in substantially the form as attached, upon approval and execution thereof by the City, and to carry out and fulfill the provisions and requirements thereof.
- 2. The HRA hereby makes formal request to the City Council to issue the Bonds to refund the outstanding Series 2007D Bonds.
