## **Updates**

NDDC - Food Crawl event was a success. 3,000 tickets were sold. For next year, the NDDC will build off the success and increase the attendance of the event.

CVB - The CVB just rolled out their new television commercial for the Southeast MN region. Continued planning and marketing for the Superbowl is underway. A Superbowl visitor package is being put together by the CVB. The Vikings will make an appearance for Defeat of Jesse James days on September 9.

City - City Administration has continued discussion on the relocation of the Northfield Liquor Store. The impact of the developments in Dundas on Northfield will continue to be topic of community development discussion.

Chamber - The Chamber Golf Tournament was a success even though there was rain. The Chamber Board is considering the real possibility of relocating the Chamber to another facility. The Chamber welcomes partnership with other organizations to make the move successful.
