IV. Unfinished Business

2. <u>17-1041</u> Discussion about Climate Action Plan and Engagement other Boards and Commissions.

Kim attended the September Park and Recreation Advisory Board meeting where she introduced the climate action plan (CAP). She feels it is important for EQC members to reach out to other boards and commissions to inform as well as involve them in the CAP. Matt felt it was important for EQC members to have enough background information to know what is happening with the CAP before going forward to other boards and commissions. After being invited back to PRAB, Kim has put together a presentation explaining the beginning steps to organize a CAP which she will give at the October PRAB meeting. EQC members discussed what additional boards and commissions to share the presentation, which included EDA, HRA, Human Rights, PRAB, and Planning Commission. The GNSC would like to organize an educational community event for the CAP in the first quarter of 2018. CERTS grant money is available with an October 20, 2017 application deadline. GNSC will apply for the grant.

A motion was made by Board Member Miller, seconded by Board Member Rohn.

The City of Northfield Environmental Quality Commission (EQC) requests that the Greater Northfield Sustainability Collaborative design and implement an educational event for the City's Climate Action Planning process with the following action items:

Organize a public summit to bring together community members. This summit's goals should be to educate about local climate change impacts and provide space for dialogue.

Gather and organize public input from summit into a report for the EQC. The GNSC consists of staff, faculty, and students from both St. Olaf and Carleton, in addition to community members. The City will assist this group by advising the GNSC and publicize the event. The GNSC will report updates at the monthly EQC meetings. The EQC will provide feedback and communicate information gained from the event and names of people interested in being involved in climate action planning.

The motion carried unanimously.

V. New Business Items

3. <u>17-1042</u> Discussion of the "1 Watershed 1 Plan" effort by Cannon River Watershed Partnership.

Matt Rohn attended and reported back on a Cannon River Watershed Partnership program entitled "1 Watershed 1 Plan". EQC members felt it was important to support the work they are doing to move together to develop a reginal plan. Discussion was held on appointing a "watershed champion". Youth member, Katie will share more about the program at the November EQC meeting.

Justin Wagner shared the MnTAP WWTP efficiency findings with EQC members.
