2. <u>18-121</u> Presentation from Environmental Quality Commission (EQC)

Kim Smith, Environmental Quality Commission Chair, reported on the formation of a Climate Action Plan which is included in the Strategic Plan. The Mayor will be appointing an advisory board that will report to the EQC. Some of the items that may affect the Downtown Historic District include transportation, streetlighting and stormwater runoff. A tentative timeline for completion of the plan is December 2020. Boards and commission members will have an opportunity to review the plan prior to completion.

III. Unfinished Business

3. <u>18-122</u> 501, 503, & 505 Division Street Renovation Project

Staff updated the commission on the revisions to the old Reub 'N' Stein building. They have decided not to install a corner window after locating the original windows on the inside. Demolition permits have been pulled but final plans are still being worked on.

V. Reports and Discussion Items

Staff reported on the Heritage Preservation Site Designation item that was passed by the City Council on February 20, 2018. The next step would be to submit an application to the National Registry. He spoke with Carole Zellie and she informed him it would cost \$5,000 to prepare the application. The HPC could extend her contract by adding an addendem to perform the necessary paperwork.

The sign sub-committee gave a report on the Wickert sign at 5th and Division Street.

The commission discussed establishing a better working relationship with the Northfield Downtown Development Corporation (NDDC) and would like to invite Executive Director Jenni Romey to a future meeting.

A motion was made by Board Member Thomas, seconded by Board Member Clark, to direct staff to proceed with extending the contract with Carole Zellie to submit the national registry application. The motion carried by the following vote:

 - B. Evans commended youth member Logan Ledman for winning the Voice of Democracy Award and a chance to receive a \$30,000 grant in Washington D.C. She also recognized youth member Hannah Pahs for receiving a Volunteer of the Year Award from the Historical Society.

B Evans also reported on the following:

- MNSAH (Minnesota Society of Architectural Historians) will be sponsoring a trip to Northfield in September and will concentrate on Carleton and the Historic Downtown areas.
- In April and May she will be teaching a class in the Cannon Valley Elder Collegiium on Northfield Architecture.
- She will be giving a talk to a chapter of the P.E.O. on J.C. Nutting and the three buildings he built.
- She is also working with Cathy Osterman at NHS to establish at least two walking tours during "May is Preservation Month" that NHS will be doing in place of previously held "June is History Month' celebrations.

A motion was made by Board Member Mohring, seconded by Board Member Evans, to have the HPC Chair sign a letter of support for the Main Street program and forward to the affiliate organization. The motion carried by the following vote:
