CITY OF NORTHFIELD, MINNESOTA CITY COUNCIL RESOLUTION 2018-075

RESOLUTION APPROVING PROPERTY TAX ABATEMENTS

BE IT RESOLVED By the City Council of the City of Northfield, Dakota and Rice Counties, Minnesota (the "City") as follows:

Section 1. Recitals.

- (a) The City proposes to (i) undertake certain public improvements to various city parking lots with tax abatement bonds authorized by the Minnesota Statutes, Sections 469.1812 through 469.1815 (the "Act") and (ii) authorize a property tax abatement with respect to various parcels of land to finance City parking lot components of various public improvements as part of the 2018 improvement projects (the "Project"). The City proposes to use property tax abatement pursuant to the Act to finance the Project. The proposed term of the abatement will be for up to 10 years in an estimated not to exceed \$300,000. The abatement will apply to the City's share of the property taxes (the "Abatement") derived from the property described by property identification numbers on the attached **Exhibit A** (the "Property").
- (b) On the date hereof, the Council held a public hearing on the question of the Abatement, and said hearing was preceded by published notice thereof in accordance with the Abatement Law.
- Section 2. <u>Findings for the Abatement</u>. The City Council hereby makes the following findings:
- (a) The Council expects the benefits to the City of the Abatement to at least equal the costs to the City thereof.
- (b) Granting the Abatement is in the public interest because it will help finance the acquisition and construction of public facilities in the City, preserve tax base and help finance public infrastructure.
 - (c) The Property is not located in a tax increment financing district.
- (d) In any year, the total amount of property taxes abated by the City by this and other resolutions, if any, does not exceed the greater of 10% of the net tax capacity of the City or \$200,000.
- Section 3. <u>Terms of Abatement</u>. The Abatement is hereby approved. The terms of the Abatement are as follows:
- (a) The Abatement shall be for a maximum of 10 years and shall apply to the taxes payable in the years 2019 through 2028, inclusive.
