Tempel reviewed several administrative updates.

Discussion was held on:

- -the Ford Street profile for Bluff View and ways to potentially alleviate costs for the project -possible topics to explore further from the ULI Workshop
- -Heisler noted she attended the ULI workshop and felt infrastructure is one way the City can control costs and felt looking at the return on investment for street standards and infrastructure would be of value
- -Schroeer would like the ULI workshop PowerPoint and data made available to everyone and offered to present the information to the Council
- -the upcoming Bicycle and Trail System survey meetings

Tempel noted Comm. Dev. Director Chris Heineman has accepted the City Administrator position with Little Canada. Schroeer asked Tempel to pass along the Planning Commission's congratulations to Mr. Heineman.

Continuing Discussion on Accessory Dwelling Units (ADUs)

Tempel began the conversation on ADUs and felt a code revision could move forward before the end of the year. Tempel stated he would complete a draft text amendment for PC review and then gather input from the Housing and Redevelopment Authority, Economic Development Authority and City Council.

The consensus from the PC members was to make the make the policy easy to execute for staff and the community.

Discussion was held on:

- -where ADUs should be permitted
- -any obstacles in the Land Development Code creates
- -the definition of an ADU
- -size limitation (square footage cap)
- -excluding ADUs from the Building Area Ratio percentage
- -rental licensing
- -parking requirements
- -design and aesthetics
- -removing the 8,000 sq. ft. lot size requirement
- -adding further reasoning to the purpose statement in regards to ADUs

IV. Reports and Discussion Items

Buckheit noted streets.mn has a post on the City of Minneapolis and the City of St. Paul's ADUs policy's.

Schroeer noted the Minnesota Housing Task Force reported the need of 300,000 additional homes by 2030 to help with the affordable housing shortage.

Heisler noted she is on the Northwest Area Planning Advisory Committee and they are making a recommendation for a consultant to analysis the area west of the hospital.

Wehling noted he did not know of other youth members planning to serve on the board. Wehling stated he would have time to send a parting memo to the PC.
