Acquiring a translation equipment for the Northfield community will make the community more inclusive and welcoming. The equipment will allow for groups with a different native language than English to have access to talks, events and City Council meetings, among others, by allowing people to wear a head piece while the translator transmits the English speech into their native languages. This equipment, obviously, does not provide a translator but allows for two languages to be used at the same time while live translation requires more time as the speech has to be repeated in the targeted language.




