10. [19-740](#) Discuss Pedestrian, Bike and Trail System Update Recommendations.

Streets and Parks Manager Behrendt introduced Connor Cox from Toole Design. Cox provided an update on the project and the draft of the Pedestrian, Bike and Trail System Recommendation. Cox briefly explained next steps in the project. Public Works Director/City Engineer Bennett answered questions posed by council.

Don McGee, 710 Highland Ave, expressed his concern with the 5 year plan and the amount of money being spent and nothing being done; wants this project done this year.

Sue Hollinger, 13227 Faribault Blvd, spoke regarding her concerns of the trail recommendation and impact to Calvary cemetery.

Council took a 5 minute break at 8:16 PM and resumed at 8:26 PM

11. [19-741](#) Consider Approving Concepts for the 2019 Street Reclamation Project (Third Street)

Engineering Manager Simonson briefly updated council on the public engagement process on the 2019 Street Reclamation Project. Simonson introduced Jonathan Nelson from Bolton & Menk. Nelson presented the two design options for the Third Street

Corridor. Simonson advised council direction is needed and mentioned the upcoming neighborhood meeting. Simonson and Public Works Director/City Engineer Bennett answered questions posed by council.

David Nitz, 402 Highland Ave., member of St. Johns Church, confused with the handicap design.

Ruth Neuger, 1510 Rolraag Court., strong vote for option 2. Number of events are held at the church; expressed her concern with safety and recommended lights. Is in favor of a handicap option for the Arts Guild.

Don McGee, 710 Highland Ave., expressed his concerns with the Raider Derby. His grandkids participated in this derby last year, and stated with the possible curb extensions this race would be dead as they need every square foot they can get.

Tim Peterson, 1401 Heritage Drive., Guild plaza was not something they asked for. However, would like to be included in the overall design. Concerned with safety, i.e., drop off and pick up zone. Expressed would be great to have a handicap ramp. There are already issues for parking with neighbors.

Will Schroeer, 206 Winona Str., researched safety and spoke regarding a recent study performed on curbside and the amount of crashes involved with pedestrians attempting to cross and drivers not stopping. He would like to see more bump outs on all four sides of the street.

Charlette Willis, across from the Northfield Arts Guild, spoke regarding safety and snow removal. Encroaching is a big concern, stated they have called police but nothing is done. If they want the residents in this area to take care of snow removal it will not happen since all are older citizens. Asked who is paying for this.

Pam Fickenscher, Senior Pastor at St. Johns, many outside services use St. John's facilities for events. Every Wednesday a free meal is provided and normally 200 people attend. She would like to see concept #2.

A motion was made by Council Member Zweifel, seconded by Council Member Nakasian, to approve the attached recommended design concepts for the 2019 Street Reclamation Project (option #2).

A motion was made by Council Member Grabau, seconded by Council Member Nakasian, to amend the motion to keep the bump outs but take away the design features previously mentioned, at the two western most bump outs at Plum and Orchard.
