PRESENTATIONS

Police Chief Nelson provided an update on the Spring Flood Outlook. The National Weather Service (NWS) is predicting the river will remain very high for the next month. Cannon River has remained at 897'+ over the last week. Flood stage is 897. The NWS is predicting Northfield at a 60% chance of reaching major flood stage this spring (900'+). Nelson reviewed the NWS predictive software showing predicted river levels and reviewed current flood preparation activities including meeting with staff for City infrastructure, meeting with businesses/properties affected, and volunteer efforts underway through Northfield Shares. Nelson reminded everyone to sign up for Northfield Emergency Weather Alerts via Everbridge. Nelson noted because of the new gauges and NWS information, flood information can be sent out specific to Northfield. Public Works Director/City Engineer Bennett provided information on the 2019 Flood Wall Study that will be completed this year and answered questions posed by Council. City Administrator

Martig provided information on City of Northfield Climate Action Plan.

Met with a neighbor in the area who would meet with anyone willing to talk about putting a sidewalk on his property. Asked Council to come up with a plan to install a sidewalk.
