# 19-763: Driving Licenses for All	<ul> <li>Valdecantos introduced the 2019 legislative activity regarding Driving Licenses for All (DLA), including a report on the five meetings with various State House of Representative Committee meetings, which she and other Northfielders have attended. Handouts were provided as informational materials with the agenda packet.</li> <li>Rebecca Lucero, MN Department of Human Rights Commissioner, advocates on behalf of the Governor Waltz and Lieutenant Governor Flanagan for the DLA legislation. She has testified at the hearings with various House committees. There is optimism about a vote on the issue in the House but not in the Senate where the bill has not been introduced yet (as of March 14).</li> <li>Commissioner Fowler inquired how does this relate to the City ID. Response was it is still useful for non- drivers in communities with City IDs. Commissioner Iqbal asked what documentation will be needed. Response is that a social security number is not required. Commissioner Miron commented that driving is a right not a privilege enabling access to work, schools and services.</li> <li>Valdecantos updated that ISAIAH organization will meet on April 7 meeting with Senator Draheim at St. Dominic's at 1:45 p.m. (after Spanish Mass).</li> <li>Lucero followed her presentation with a personal introduction and overview of her goals at the MN Department of Human Resources.</li> </ul>	DeBeau moves to pass a resolution in support of Driving Licenses for All. Fowler seconded. The HRC unanimously passed a resolution in support of the Driving Licenses for All.

	Her goal is to bring the law and justice together, and work on healing within the community. Disability (1), race (2), and sex (3) are the 3 highest discrimination cases brought to the Dept. Lucero and her department intend to work pro-actively on enforcement, education, compliance, legislation as well as on trainings offers throughout the state for which there is a lot of demand. Her agenda in three words: change the world.	
#19-765 Accessory Dwelling Units presentation	<ul> <li>Betsey Buckheit: Northfield Planning Commission presentation on ADUs and Equitable Street Design. Handouts were provided with the agenda materials for reference.</li> <li>ADUs are just one tool to add living spaces to address the demand for affordable housing in Northfield. Explanation of the zoning and rental ordinances that are currently in place and prohibit the construction of ADUs in much of Northfield. ADUs are not necessarily, but likely to be more affordable (do not require major new infrastructure projects, will be small, will be new and thus more energy efficient). It is a flexible tool that can be added to the toolbox of housing options in Nfld. For the ADUs to be successfully the Planning Commission strongly recommends flexibility in policies and descriptions, citing the differences in experiences in St. Paul and Minneapolis.</li> </ul>	
	Buckheit then gave an introduction to the Planning Commision's evolving thoughts on Equitable Street Design planning. There is grave inequity in accessibility to the services (including education) in Northfield, and future intentional street planning and repairs as more than just a technical way to "fix" the roads, can start remedying the currently existing inequity issues. The Planning Commission urges to look at street "projects" as an issue of public right-of-way to increase connectivity throughout the community. The communities most inadvertently affected by current

	Terrace and Florelas Park at the

	issue. Buckheit encouraged	
	collaboration between HRC, HRC

	location for such training in Nfld, Joan referred to the black church	
	tradition of bringing people to a	
	location they already frequent, which	
	would be St. Dominic's in Nfld.	
	Other suggestions were to offer	
	childcare (by 3 <sup>rd</sup> party) during the	
	training, and since the training will be	
	provided in English a glossary of	
	frequently used vocabulary in this	
	context.

#19-766	<ul> <li>Dorothea Hrossowyc joined the conversation on how to move forward with the City's intent to recognize that Northfield is located on land once occupied by indigenous peoples. Clarice Grabau: Both Colleges will collaborate with the City to come to a good understanding of indigenous land use or ownership in our area through archival research.</li> <li>Clarice called for putting a committee together with members of the colleges, the city, and others from the community and looks for HRC members on the Committee. Mar Valdecantos and Larry Fowler agreed to join such a committee. It was suggested to make sure to reach out to native Americans living in Northfield, independent of tribal affiliation to these tribae substances.</li> </ul>	Create a committee to work on this: HRC members to join this committee: Larry Fowler, Mar Valdecantos.
