
WHEREAS, such statute and rules required that a Local Government Unit (LGU) accept or delegate the authority for administration of the act and rules; and

WHEREAS, the Board of Water & Soil Resources has requested notification of such action; and


WHEREAS, the City of Northfield wishes to continue the LGU relationship with the Rice County Soil & Water Conservation District.



The Rice County Soil & Water Conservation District previously assumed responsibility as the Local Governmental Unit (LGU) for the interim rules of the Wetland Conservation Act. The final rules are now in place and the SWCD has agreed to continue its responsibilities as LGU for administrative and technical services for wetland alterations. In order to act as the LGU for wetlands existing within your municipal limits, the City Council of Northfield must adopt the attached resolution transferring responsibilities under the Wetland Conservation Act to the Soil and Water Conservation District. This resolution will then be forwarded to the Board of Water & Soil Resources as required.

The Rice County Soil & Water Conservation District will process requests for wetland alterations pursuant to the act and rules. These rules require the appointment of a technical panel and a member of the city council or a staff person will be asked to participate when permit applications are reviewed. The SWCD will advise you of the process for permit review and establishment of a technical panel, should a citizen request be filed.

Please have your council act on this resolution and return it to me as soon as possible so that I may forward it to the Board of Soil & Water Resources.
