An additional Street and Parks Operator Horticulturalist

The Streets and Parks division of the Public Works Department is requesting an additional Streets and Parks Operator in 2020 and Horticulturalist in 2021. The request is being asked for based upon current workload and staffs inability to meet these workloads, for items such as park maintenance, athletic field maintenance, mowing, trimming, and street patching.

In terms of comparable City's, in 2019 the City added an additional Street and Parks Operator bringing the City's operator staff to 6. Comparable City's still have near double the maintenance staff or more.

- Northfield Street & Parks –6 Street & Parks Operators = 6 FTE
- Faribault Streets 7 Street Operators & & 5 Parks Maintenance = 12 FTE
- Rosemount Street 5 Operators & 5 Parks Maintenance = 10 FTE
- Owatonna Street 4 mechanics, 12 Operators & 6 Parks Maintenance = 18 FTE, they also have two parks FTE at the golf course that help in parks maintenance in the offseason.

With all of the street and park work, staff resources can't keep up with workload. Staff will monitor how we are keeping up on workload, but staff believe workload needs will be able to show a need for at least a department of 9 Street and Parks Operators and 1 Horticulturist.

Horticulturist

The City has a beautiful downtown with flowers and gardens adding to what makes it special. The City hears from the Northfield Garden Club about concerns with being able to keep up with planting and maintenance of these planting beds.

This position would be responsible for coordinating planting and maintenance of these beds, along with assisting with Forestry inquiries from residents related to boulevard trees. A summary of some of the planting beds are below.

- Signage on Hwy 3 and Hwy 19
- Flower Baskets
- TH 3 and Third
- Second Street/Washington Street Hillside

- Washington St. Parking Lot,
- Mill Towns behind Just Food
- Lions and Riverside Park plantings and flower beds
- Riverwalk pots and plantings
- Spring Creek Everybody's Park Plantings
- Division and Seventh Landscaping
- Etc.

If the request does not take place, the Streets and Parks Division will continue to fall further behind in maintenance items.
