Goal: celebrating and honoring our community. Not just a meal but it will be time to mingle, enjoy art, poetry (Rob Hardy, Poet Laureate), music, Cecelia Cornejo's The Wandering House (a projected sponsored by the HRC). 500 registrations to date, and the fundraising is also going well. Donations and Volunteers welcome. Important time to unite people in our community. Shafqat offered to Nancy to film it with his drone.

TMP-5246 International Day of Peace Event – September 21	Mar will meet with Leonard Sisters and their mom 3:45 p.m. at the Golf Course on Friday. UN theme is: Climate Action for Peace. Rather than following the previous format of presentations the idea is to include a more inter-active peace fair.	
TMP-5255 Municipal ID Ordinance	Beth checked into how City IDs are used. The Library asked for feedback in its June newsletter and there was no response. NPD (Chief Nelson) reports that they do not routinely ask for IDs at police stops. Enrique and Mar looked into training employers on accepting the Municipal IDs, so that all their employees will become familiar with it. The original information sheet is very relevant still.	Next step: distribute it to businesses, make a list, talk to Chamber of Commerce.

	Mar: it appears legally impossible to replace the legal name by just initials, as legally changing one's name is costly. NYC offers clinics to transgender people on the legal aspects of the transgender process and provide financial support for the court costs of changing a name. Northfield might want to explore doing something similar, perhaps through CAC.	
TMP-5261 Voting Members	The Mayor is open to a one-time switch to become a non-voting member. Regarding the HRC's request that each Youth Member receives full voting rights, Beth is checking on this with other Boards and Commissions to get their opinion.	
TMP-5258 Najwa Community Picnic	Location: should we stick to Greenvale? Richard calls for more universal advertising, months out. All agreed. Perhaps move to dinner time was also considered.	Decision: DATE: JUNE 27, 2020 Decision: VENUE: There was an overall preference (Larry and Shafqat in disagreement) for having the event always take place at the Greenvale location (like in 2018). However, the construction of the new school next to this site might interfere with this for 2020. HRC will revisit this at its January 2020 meeting when a timeline on the construction might be available.

Workforce Housing Summit	<p>Rice County Housing Summit report by Clarice Grebau Clarice, Mar, and other Northfielders were in attendance. Two main factors re housing are affordability and availability. Participants heard from various city officials in southern MN, as well as various employers. Common thread: this problem will not be solved by building more single-family housing. Greater housing density is needed to solve this issue. Clarice also alerted the HRC re the plans for a 79 Unit apartment at 5th and Washington.</p> <p>Mar noted that St. Peter, MN, has many model programs/resources for housing that Northfield does not; Clarice noted that in the case of St. Peter there were different development and funding sources (City Funding). A general discussion of housing needs in Northfield ensued.</p> <p>Beth K. noted that Housing is the bailiwick of HRA, and invited/encouraged HRC members to attend the HRA meetings.</p>
