#### **REPORTS FROM THE MAYOR AND COUNCILMEMBERS**

*C.* Nakasian - Attended the Riverfront Committee meeting, met with Mayor Pownell regarding a proposal to redefine the Transportation Advisory Committee, attended the Midwest Interstate Passenger Rail Commission meeting as an observer, noted the Minnesota rail line figures well in the larger regional rail planning. Attended Little Shop of Horrors play at the High School.

*C.* Zweifel - watched the League of Minnesota Cities Tobacco 21 Webinar. Noted it is a great resource and there are currently 53 cities that have adopted T21. Represented the Mill Towns Trail at the Capital Bonding Tour. Attended the HRA work session where the HRA reprioritized their work plan. Volunteered at Greenvale Park Day of Dead event. Visited NRC and heard their biggest concerns being crossing Cannon Valley Dr. to 1000 Cannon Valley Dr., improved Hiawathaland Transit express service to Target and Aldi's, appreciate if Take It To the Box Day could come to them.

*C.* Ness - Attended Hospital Board meeting. Discussed mix of payers over the past month.

C. Grabau - Attended Council Employment Policy Committee meeting, Capital Bonding tour, NAFRS ribbon cutting, board/commission training, land acknowledgement meeting which is a sub group of the Human Rights Commission, attended the Women in Public Service conference at Hamline with Mayor Pownell and attended the second Capital Bonding tour today.
